Samples must be shipped in crates marked "Sélections Mondiales des Vins Canada 2017" in highly visible letters and include the following items :

- A copy of the registration form (s) ;
- A photocopy of the certificate of analysis;
- **A pro forma invoice** containing the following information :
 1. Name of the wine
 2. Color
 3. Alcohol Content %
 4. Number of samples per product (3)
 5. Bottle format in ml (750 ml)
 6. Ex-cellar, net and commission-free export price, i.e. the resale price in EUR, USD or CDN;
 7. Total value in EUR, USD or CDN
 8. Currency in EUR, USD, CDN
 9. **Country of origin and mention stating : « Competition Samples – Value for customs Purposes Only ».**

THE TERMS FOR SHIPMENTS

IMPORTANT : Please note that it is illegal to send alcoholic beverages by mail in Canada. Any wines shipped in this manner will be destroyed by Canada Post.
