Samples must be shipped in crates marked "Sélections Mondiales des Vins Canada 2018" in highly visible letters and be accompanied by the following documents:

A copy of the registration form(s)  
Certificate(s) of analysis

A pro forma invoice indicating the following information:

1. Full address of the producer;
2. Full address of Sélections Mondiales des Vins (SMV) Canada;
3. Name of the wine;
4. Color;
5. Alcohol content (%);
6. Number of samples per product (3);
7. Bottle format in ml (750 ml);
6. Ex-cellar, net and commission-free export price, i.e. the resale price in EUR, USD or CDN;
7. Total value in EUR, USD or CAD;
8. Currency in EUR, USD, CAD;
9. Country of origin;
10. Mention stating "Competition Samples – Value for Customs Purposes Only".

## **SHIPPING INFORMATION**

**IMPORTANT:** Please note that it is illegal to send alcoholic beverages by mail in Canada. All products shipped in this manner will be destroyed by Canada Post.

If you choose to use courier delivery companies such as FedEx, DHL, UPS etc., you will be billed a \$50 brokerage fee PER PRODUCER upon registration because such companies cannot clear alcoholic products at customs for SMV Canada.
