SAMPLES MUST BE SHIPPED IN CRATES MARKED "Sélections Mondiales des Vins Canada 2019" IN HIGHLY VISIBLE LETTERS and be accompanied by the following documents:

- Certificate(s) of analysis
- A **pro forma invoice** indicating the following information:
  - Full address of the producer;
  - Full address of Sélections Mondiales des Vins (SMV) Canada;
  - Name of the wine;
  - Color;
  - Alcohol content (%);
  - Number of samples per product (3);
  - Bottle format in ml (750 ml);
  - **Ex-cellar, net and commission-free export price, i.e. the resale price in EUR, USD or CDN;**
  - Total value in EUR, USD or CAD;
  - Currency in EUR, USD, CAD;
  - Country of origin;
  - **Mention stating "Competition Samples – Value for Customs Purposes Only"**
  - **IMPORTANT: PRO-FORMA INVOICES STATING A VALUE OF \$1 OR €1 PER BOTTLE WILL NOT BE ACCEPTED.**

Sélections Mondiales des Vins (SMV) Canada assumes no responsibility or liability for samples that are lost or damaged during shipping or shipments that are improperly addressed or received after the specified deadlines.

## SHIPPING CONDITIONS:

**IMPORTANT :** In Canada, it is illegal to send alcoholic beverages through the mail. Any wine products sent in this manner will be destroyed by Canada Post.

- The terms for shipments sent via courier delivery companies (FedEx, DHL, UPS) are: “DAP Quebec - Customs Clearance Not Included”.
- Wine products are cleared at customs by Eurofret Canada. Please note that each producer will be charged a \$50 brokerage fee for this purpose.
